- For part 61 training make sure you have all items listed completed: (61.129 requirements)
 - a. 250 hours of flight time, 100 hours of which must be in powered aircraft, and 50 must be in airplanes.
 - b. 100 hours of pilot-in-command time, 50 of which must be in airplanes and 50 hours in cross-country flight of which at least 10 hours must be in airplanes.
 - d. 20 hours of training, including 10 of instrument, 10 of complex or TAA.
 - e. One 2-hour cross country flight in a single engine airplane in daytime conditions that consists of a total straight-line distance of more than 100 nautical miles from the original point of departure.
 - f. One 2-hour cross country flight in a single engine airplane in nighttime conditions that

consists of a total straight-line distance of more than 100 nautical miles from the original point of departure.

- g. Three hours in a single-engine airplane with an authorized instructor in preparation for the practical test within the preceding 2 calendar months from the month of the test.
- h. Ten hours of solo flight time in a single engine airplane or 10 hours of flight time performing the duties of pilot in command in a single engine airplane with an authorized instructor on board that include:
 - -One cross-country flight of not less than 300 nautical miles total distance, with landings at a minimum of three points, one of which is a straight-line distance of at least 250 nautical miles from the original departure point.
 - -5 hours in night VFR conditions with 10 takeoffs and 10 landings (with each landing involving a flight in the traffic pattern) at an airport with an operating control tower.
- o For part 141 training make sure you have all items completed: (appendix D to part 141)
 - a. Graduation certificate.
 - b. 55 hours of flight training from a certificated flight instructor and the experience requirements as stated for part 61 above.
- Log book endorsements: Note, the language for the following 4 endorsements are from AC
 61-65h.

Practical test 2 calendar month endorsement: 61.39(a)(6)(i) and (ii).
